## Terms and Conditions

1. By entering into the Phyllis Tuckwell Red Hot Summer Super Draw, entrants agree to be bound by these terms and conditions.
2. Participation in the Phyllis Tuckwell Red Hot Summer Super Draw costs £1 per ticket.
3. There are no restrictions to the number of entries one person can make. However, the operator has a responsibility of care towards its players, to identify any signs of potential irresponsible gambling and raise the issue accordingly.
4. Monies raised by the Phyllis Tuckwell Red Hot Summer Super Draw will go towards the work of Phyllis Tuckwell to provide specialist palliative care.
5. Payment for participation in the raffle can be made by cheque (made payable to Phyllis Tuckwell Hospice) credit / debit card or cash.
6. Phyllis Tuckwell is unable to accept payment for participation in the super draw by credit card over the telephone or online.
7. The ticket is in two parts. The left-hand, smaller section of the perforated ticket, known as the 'counterfoil', is to be returned and physically entered into the draw. The right-hand, larger section of the ticket, known as the 'ticket', must be kept by the player and produced (upon request) to claim any related prizes.
8. Your raffle tickets (ticket 'counterfoils') will be entered into the draw as soon as the whole payment is received.
9. The promoter accepts no responsibility if the chosen method of payment is cancelled in error.
10. No responsibility is taken for raffle tickets and payment lost, delayed or damaged in the post and proof of posting will not be accepted as proof of receipt.
11. Closing date for the receipt of raffle ticket counterfoils and raffle ticket payment by cheque or credit card in the post to Phyllis Tuckwell is Friday 10<sup>th</sup> September 2021 at 5pm. Tickets received after this date in the post may not be entered in the draw.
12. Any tickets received after the above dates and time, and deemed too late to be entered into the draw, will be retained, and the monies will be treated as a donation.
13. The Phyllis Tuckwell Red Hot Summer Super Draw will take place on Friday 17<sup>th</sup> September 2021, at the Phyllis Tuckwell Hospice building at 11am. Entrants do not need to be present at the draw to be eligible to win a prize.
14. Phyllis Tuckwell reserves the right to change the date and/or time of the draw.
15. Raffle tickets will be drawn randomly. The first ticket number drawn will receive the first prize of £2,000 cash. The second ticket number drawn will receive a cash prize of £500. The third ticket

number drawn will receive a cash prize of £250. The next 20 ticket numbers drawn will receive a cash prize of £50 each.

16. Tickets and payment received by 5pm on Friday 30<sup>th</sup> July 2021 will be entered into an Early Prize Draw for the chance to win a £100 Love2Shop gift card. One raffle ticket will be drawn at random on Tuesday 3<sup>rd</sup> August at the Phyllis Tuckwell Hospice building at 11am.
17. Tickets are non-transferable.
18. The promoter reserves the right to change the details and availability of any of the advertised and listed prizes at any time.
19. Winners will be notified by telephone and/or post. Any prize not claimed after a period of three months from the date of the draw will revert automatically to Phyllis Tuckwell.
20. Phyllis Tuckwell staff are eligible to take part in the raffle *unless* they are the named promoters, or work or volunteer in Fundraising or Finance. Ineligibility extends to the immediate families of the above.
21. All entrants are solely responsible for providing Phyllis Tuckwell with their accurate and up-to-date contact details, and Phyllis Tuckwell will be in no way liable for any failure or inability to contact any entrant due to any errors, omissions, illegibility or inaccuracies in the contact details that the entrant has provided. In the event that an entrant changes their contact details, they will be solely responsible for advising Phyllis Tuckwell of the change.
22. By accepting a prize, the winners agree to take part in any promotional activity deemed appropriate by Phyllis Tuckwell. Phyllis Tuckwell reserves the right to use the name of the winners, their photograph and audio and/or visual recordings of them in any publicity, unless prior notification has been received.

24. The draw will be overseen by the promoter/operator and in the presence of two independent witnesses.
25. The Phyllis Tuckwell Red Hot Summer Super Draw raffle is open to all mainland Great Britain residents over the age of 16 (this excludes Northern Ireland, Isle of Man and Channel Islands). The tickets may not be sold to, or by, or for, a person under 16 years of age.
26. Phyllis Tuckwell will, where appropriate, carry out checks to verify that a player is over the age of 16. If a prize winner is found to be under the age of 16, we will refund their money and withhold the prize.

33. Phyllis Tuckwell reserves the right to disqualify any entrant if it has reasonable grounds to believe the entrant has breached any of these rules.
34. Each entrant should retain a copy of these terms and conditions for their reference.
35. Phyllis Tuckwell's Red Hot Summer Super Draw 2021 is a form of gambling. Participants are encouraged to gamble sensibly.
